## How to claim the Reward

4. Bulldogs Members may claim the Reward by following the procedure set out below.
  - a. Bulldogs Members interested in purchasing a new Vehicle must contact the Bulldogs Membership team on 07 9789 8000 or [membership@bulldogs.com.au](mailto:membership@bulldogs.com.au). The Bulldogs Membership team will validate the customer's membership. Once the membership has been validated, the Bulldogs team will send the Member a letter via email (or post where Member does not have email access) which will contain a unique code (**Membership Number**) that is required for the Member to redeem the offer and which will contain instructions on how claim the Reward (**Claim Letter**). The unique code can only be used once and can only be processed by the Member with respect to one Vehicle purchased by that Member during the Offer Period.
  - b. Once the Member has received the unique code, the Member is eligible to claim the Reward on the purchase of a new Kia Vehicle.
  - c. The Member may then visit any Kia dealership in Australia, to negotiate the best deal on their preferred Vehicle and present the letter and their 2019 Bulldogs membership card to claim the Reward.
  - d. The name of the Member must be identical to the name of the purchaser contained in the signed copy of the Kia new vehicle sale contract signed with Kia Australia.
